Guidelines for Application:

The *Celebration of Life Annual Benefit* seeks to assist undergraduate and graduate students with the high cost of tuition, textbooks & study materials. Awards are open to individuals who are currently attending a college or university and maintain at least a 2.5 Grade Point Average on a 4.0 scale.

Applicants must provide the following:

- a) Completed application.
- b) An official college transcript
- c) A three (3) paragraph essay that expresses interest in pursuing a career in the health or sciences and demonstrated commitment to the community.

Selection Process & Notification:

Scholarship recipients are selected according to merit on a competitive basis. In addition, applicants must demonstrate career and academic potential measured by a combination of factors, including past performance and career objectives. The number of scholarships awarded will be based on application procedures and available funds. Not all applicants will receive awards. Although the committee would love to inform all applicants of their status, this is not feasible. The selection committee will contact only scholarship finalists seven (7) days prior to the *Celebration of Life Annual Benefit*.

Award & Payment:

The *Celebration of Life Annual Benefit* awards three (3) scholarships annually to determined and deserving students. The recipients will be honored at the *Celebration of Life Annual Benefit*. Awards are mailed to the student's home address upon verification of enrollment from the Registrar during Spring semester. Checks are made payable to the recipient in certified funds.

Revision & Rescission Policy:

The general conditions and procedures under which scholarships are made are subject to periodic review by L.J. HOLLOWAY & ASSOCIATES, INC., including rescission and termination.
